MS. SUSSMAN: Let the record reflect that we are in an interview room at Area 4 Violent Crimes. Today's date is January 28, 1987. The time is 9:55 a.m. Present in the room with me, Assistant State's Attorney Susan Sussman, is Detective James Mercurio, the court reporter and the defendant, Marcellius Bradford. We are here to take the statement of Marcellius Bradford

Marcellius, I talked to you earlier and explained that I am an assistant state's attorney, a lawyer working with the police and not your lawyer; is that correct?

MR. BRADFORD: Yes.

- Q And before we spoke, I advised you of your constitutional rights; is that correct?
 - A Yes.
 - Q I am going to read you your rights again.

Do you understand that you have a right to remain silent?

- A Yes.
- Q Do you understand that anything you say can be used against you in a court of law?
 - A Yes.
- Q Do you understand you have the right to talk to a lawyer and have him present with you while you are being questioned?
 - A Yes.
- Q Do you understand if you cannot afford to hire a lawyer, one will be appointed by the court to represent you before any questioning if you wish one?

A Yes.

- Q Understanding these rights, do you wish to talk to us now?
 - A Yes.
- Q Marcellius, I am going to call your attention to October 18, 1986, at approximately 1:00 o'clock or so, in the morning. Did you have occasion to meet up with Larry Ollins, Calvin Ollins and a guy by the name of Daniels?
 - A No.
- Q Did you see these individuals at the 1440 West 13th Street building?
 - A Yes:
- $\ensuremath{\mathsf{Q}}$ And from that building, where did you go with Larry, Calvin and Daniel?
 - A We walked down Loomis.
- Q And as you were walking down Loomis, did you get to the intersection of <u>Loomis and Flournoy</u>?
 - A Yes.
- Q When you got to the intersection of Loomis and Flournoy, did you see a car?
 - A No, about ten minutes after.
- Q Approximately ten minutes after you got to Loomis and Flournoy, did you see a car?
 - A Yes.
 - Q And what were you going to do when you saw this car?
 - A <u>Smash and grab.</u>
 - Q Now, would you describe what a smash and grab is?

- A Bust the window and snatch the purse.
- Q Who was in the car when you saw that car?
- A A lady that was -- the lady that was murdered later on that morning.
 - Q And was anyone else in the car with the lady?
 - A No.
 - Q How was the car stopped?

- Q When they pulled the lady in the back of the car, what happened?
- A I jumped in on the passenger side and Larry started driving.
- Q And how was the lady being held in the car at that point that you jumped in the car?
 - A I was holding her hands.
 - Q How were you holding her hands?
- A Her wrists together and her hands. I had her like this (indicating).

MS. SUSSMAN: Indicating for the record, over the back of the defendant's head.

- Q What was the lady doing as you were holding her hands above her head?
 - A She was screaming and calling us son of a bitches.
 - Q And while the lady was screaming, what did Calvin do?
 - A Calvin had a stick pushed in her blouse.
 - Q And what was he doing with his other hand? :
- A He had her around the neck, pressed against the back seat.
- Q Was the lady able to move in the hold that Calvin had her in?
- A Yes. That was when he struck her in the back of the head with a stick.

- Q After Calvin struck the lady in the back of the head with a stick, what happened?
 - A After he struck her?

- A They was holding her, but at the same time Calvin was trying to -- he poked her with the stick and struck her.

- A He was trying to take her pants off. One of her legs was out of the pants.

- Q When he pushed her in the back of the trunk, what did he do?
- A <u>He moved her leg -- her legs was still. He moved her</u> legs with his feet.
 - Q And after he moved her legs with his feet, what happened?
- A <u>He flipped his underpants down, flipped his penis out</u> and stuck his penis in her.
 - Q What was the lady doing at that time?
 - A Screaming and hollering, trying to get away.
 - Q Did the lady ever get away?
- A She stayed for three, four minutes. Then she stumbled about five feet away and fell.

- Q I am going to show you what has been marked as People's Exhibit No. 1 for identification. Do you know who that is a picture of?
 - A Yes.
 - Q Who is that a picture of?

- A The lady that was murdered that night.
- Q I am going to show you what has been marked as People's Exhibit No. 2. Do you recognize that?
 - A Yes, from a distance.
 - Q And what does this look like?
 - A Looks like the stick that Calvin had, similar to it.
- Q Now Marcellius, since you have been at the police station, have you been treated well by the police?
 - A Yes.
 - Q And have you been treated well by me?
 - A Yes.
- Q Has anyone made any promises to you or threats to you in order for you to make this statement here?
 - A No.
 - Q Are you making this statement freely and voluntarily?
 - A Yes.
- Q And are you making this statement because it is the truth about what happened on October 18, 1986?

A Yes.
