Α 7 That seminal fluid and spermatozoa 8 were detected in the vaginal swab, but no 9 interpretation could be made because of low 10 concentration? 11 That's correct. 12 The fact that seminal fluid and O 13 spermatozoa were found in these samples, what 14 does that indicate? 15 A It indicates that seminal fluid 16 was deposited vaginally. 17 That would indicate sexual 18 intercourse recently, recent to the actual 19 examination of the patient? 20 That is the most usual way, yes, Α 21 sir. 22 MR. SHIPMAN: I'll pass the 23 witness. 24 25

CROSS-EXAMINATION

2 | BY MR. WILSON:

Q You're not a doctor, are you?

A No, sir.

Q Ms. Van Winkle, my name is Howard Wilson and I represent the Defendant. This may be outside your field of expertise, but could you tell the jury how long seminal fluid or spermatozoa might remain in the body cavity that you detected?

Evidence of spermatozoa maximumly can usually -- maximumly can be determined at seventy-two hours, which is approximately three days. That's optimumly. Most often it is not nearly that long.

Q So really the only thing that you can definitely say from your report is, that sometime within three days previously this young lady apparently had sexual intercourse?

A Well, sir, again, seminal fluid itself will not be detected more than twenty-four hours usually.

Q So sometime within a twenty-four hour period prior to the examination, this young lady had sexual intercourse?
