thing he said that there was another type of blood test that can be done but you remember when they asked Cordova, he said we do not use this one particular type of blood test to this defense attorney because it is not accurate, it does not have the ninety-eight percent accuracy which they use as a minimum to be able to make certain determinations. That is why it was not used, but he found B blood of a secretor, of the same blood. I submit to you that had to be either a B or, which was in the sperm penetrated in and had to be two or three hours because he said it and then you heard Dr. Contostavlos coming up and saying why and Cordova says because of the color and examination and Contostavlos because it was a microscopic examination the fact that his sperm was still in tact, it had to be two or three hours. And in fact, the defense attorney even stipulated that Dr. Contostavlos was an expert pathologist.

Let's get down to the statements. The first statement, when they came out there and Randy Martin comes out there and this is the first time, he tried to put it on his friend, Brisbois. Now, this is quite a friend, Yarris. He tries to put it on his friend, a friend he used to have an apartment with

and not only does he do that, not only does he say Brisbois did that and did all these things, but he says, "Be real careful, because he always carries a .38."

I submit to you perhaps because Nick was hoping Brisbois was going to be shot then and there and then the whole thing would have been pushed under the rug, but remember that he says he got through and he tells you what Brisbois did, went to the mall, did these things and it was tape recorded and there was another thing he mentioned in this statement and that was the tan roof and when I asked Nick Yarris when he was on tape how did you know it was a tan roof, I guess I must have guessed it. I must have guessed that was a tan roof correctly. I must have guessed.

Now, you also remember when the tape goes on, they go over to the tape where he says two other things, and the two important things that took place as to this investigation. Beefsnatcher. That is one thing. They are trying to find the one thing. Yarris states a beefsnatcher. What do you mean a beefsnatcher? Well, a rapist. And they say, "Nick, is there anything else you can help us with?" Oh, yeah, there is a Landau roof.

Now, at that point he was not a suspect and when Martin took the statement from him about Brisbois, they were going to investigate which they did investigate Brisbois but then afterwards it started hitting and because originally they believed him, they thought it was Brisbois. They checked out his alibi and find it couldn't possibly have been Brisbois. Just when they checked out Brisbois for whatever purpose he was brought in here and they checked Brisbois out.

Now, the defense attorney says, "Gee, it must have been thought there was some type of credibility because the police went and checked the whole thing out."

Well, I submit to you if he hadn't checked it out, we'd be sitting here hearing from Mr. Stretton about this Brisbois. We can't have it both ways because there must have been some reason for them to check it out. Mitchell was the same situation because supposedly he saw something at night from across two lanes of traffic and they did investigate and they found out it could not have possibly been Mitchell.

So they originally after a time think it is
Brisbois but they also partially think what is going

on. These are the two crucial things, the Landau roof and the rape which were not made public and of course when Nick is asked about it, "I must have guessed. I guessed right. It was a tan roof."

Now, the second statement, the second statement he's confronted with it is not like Yarris comes up and says, "Hey guys, I want to call the press. I was wrong about Brisbois. I was just making that up." It was not until he's confronted with it, "I was just making it up. I was just trying to get out of prison. I was making that up."

They start talking about Theresa Kulp and this is a fellow who is love sick but however said this,
"I wanted to marry her, -- and excuse the expression,
"I should have blown her fucking head off," from that someone who is love sick, pathetic Nick Yarris, who comes up to the stand and the defense attorney says he is so pathetic and they are putting this murder on him, "Fucking bitch, I should have killed her."

Remember Theresa Kulp and how now she is married and while everything was fine for a while, how he wore dress clothes and how he never wore glasses because he was too vain. In fact, the Defendant admitted the night they met each other
